DECLARATION

In consideration of the organiser and promoter accepting an application by the driver whose name appears below for entry to an event or the series, the driver acknowledges, represents and undertakes to the organiser and promoter as follows.

1. **(Regulations)** The driver's participation in an event and the series is subject to the driver complying with the Regulations. The driver hereby confirms that he or she has read the Regulations and will not breach any provisions.
2. **(Standard)** Having regard to the circuit and the speed vehicles will reach the driver has the necessary skills to participate in an event and the series, and, the car used by him or her will be suitable and roadworthy for purpose of racing.
3. **(Risk)** The driver acknowledges that motor racing is a dangerous sport and the driver has voluntarily assumed all risks associated with participation in each event including the risk of injury or loss to himself/herself or others.
4. **(No Liability)** The driver agrees that each indemnified person shall have no liability to him or her in contract, tort or otherwise, including liability for negligence arising by reason of or in connection with the entry, participation or failure to participate of him or her in an event or the series. This paragraph does not apply to liability with respect to death or personal injury.
5. **(Death or personal injury)** The driver agrees that each indemnified person shall have no liability to him or her (but only to the extent permitted by law) for any death or personal injury arising by reason of or in connection with the entry, participation or failure to participate by him or her in an event or the series.
6. **(Indemnity)** The driver indemnifies each indemnified person and will keep each of them indemnified against all loss arising in any way out of his or her entry, participation or failure to participate in an event or the series.
7. **(Sums)** The driver/entrant will pay all entry fees requested in any entry form for an event or the series and will pay as liquidated damages for breach of the Regulations any sum (including any fine or penalty) awarded in accordance with the Regulations.
8. **(Consents)** The driver and entrant grant to the organiser and promoter all consents, licences and approvals and makes all assignments required by the Regulations.
9. **(Terms)** Terms defined in the Regulations shall apply in this declaration unless the context requires otherwise. **Indemnified Person** means the organiser, the promoter, each circuit owner or manager, each manufacturer, entrant or other driver and each of their respective employees, agents, officials and contractors. **Loss** includes liability, cost, damage, expense, fee or charge in respect of any property or person and death or personal injury to any person.
10. **(Severance)** Should any term or condition in this declaration be prohibited or unenforceable in any jurisdiction, that term or condition will be ineffective as to that jurisdiction to the extent of the prohibition or unenforceability. That shall not affect the validity or enforceability of that term or condition in any other jurisdiction or the validity or enforceability of any other term or condition.
11. **(Law)** The Regulations and this declaration are governed by the laws of Hong Kong. The driver and entrant submit to the non-exclusive jurisdiction of the Hong Kong courts.
